Our mission is to improve lives through education. We envision a world where everyone has access to a quality education, is aware of this opportunity and has the resources to take advantage of it. Our work is grounded in the knowledge that an education gives people choices, and leads the way to a better and healthier life. Educated moms and dads raise educated sons and daughters. It's a cycle. The world still has problems, but billions of former students are tackling them.

Reach sends ninth-grade students to high school who otherwise would not go. In rural Chiapas, less than half of middle school graduates continue their education. Reach aims to end this problem by giving small, well-timed scholarships that help students cover their high school entrance exam fees, costs of school supplies and school uniforms in small instalments every semester they remain in school.
Total expenses are \$197,826 (actual expenditures) + \$16,017 (in-kind donated professional services) = \$213,843

4b (Code: Impulsando) (Expenses \$ 90,588 including grants of \$ 58,411) (Revenue \$)
In collaboration with Ford Foundation and United Way in Mexico, Escalera is piloting a scholarship program in Chiapas and Oaxaca where 100 students will receive three years of maintenance grants to help them stay in school and achieve their dreams.
dreams.Total Expenses are \$90,589 (actual expenditures) + \$1,942 (in-kind donated professional services) = \$92,531

Escalera seeks to improve lives through education in innovative, cost-effective ways. Employment opportunities in Chiapas are scarce and even a good education does not guarantee a job. Instead, many students will need to create their own enterprises to generate income. We are using a best-practice curriculum to pilot a program for teaching these skills to high school students.
Total Expenses are \$42,815 (actual expenditures) + \$6,986 (in-kind donated professional services) = \$49,801

Escalera continuously monitors its scholarship and incentive programs. Prior to receiving a scholarship payment, each students submits to Escalera proof of their continued enrollment in school. Often teachers and schools submit this evidence in bulk on behalf of their students.

Escalera also receives administrative records from the state of Chiapas confirming enrollment status of students. Teacher incentives are given to volunteer teachers who administer Escalera's entrepreneurial curriculum in their classroom. Only teachers who submit proof of curriculum implementation receive the incentives.

The total of 512 volunteers includes a number of staff who are not considered in Part I, Line 5 because their compensation is from a related organization or is paid in Mexico as per Mexican employment obligations and as such Escalera is not required to submit Form W-3. These volunteers and staff include: 6 board members; 1 CFO who is compensated by a related organization; 1 part-time admin volunteer; 5 full time staff in Mexico; 7 school construction volunteers and interns; 20 part-time field staff; and 472 volunteers including teachers participating in Escalera's programs.

Part III, line 4d: Other program services include School Building. In 2020, Escalera had a few expenses related to its 2019 school build in Bayalemó, Chiapas. Planned additional school builds were not possible due to the Covid-19 pandemic. Studies show that a new school with decent infrastructure increases student learning time by an average of 12%. Students who learn under tarps and in shacks lose about six weeks of school due to bad weather and teachers who show up less often.

Total Expenses are \$121 (actual expenditures) + \$3,296 (in-kind donated professional services) = \$3,417
